- "Epidemic": sign of the times?





NA narratives: themes

- Wish to create understanding of addiction – and warn young generation
- Certain 'pride' about being very experienced addicts
- 13th step: carry the message outside the group?














"I have been clean now for 8 years, after having used heroin for about 20 years of my life. And during the last couple of years, I've been looking back upon my life, you know. Trying to make sense of what happened. And I have read some of your stuff as well. And what I want to add...well, the whole 12-step thing...I just feel very lucky that I came across that program, and that some American guy took the trouble to set up the first spiritual NA meeting in Holland about 25 years ago...and it is still growing. This is still just the beginning. And I feel that this is a part of the story you should take on board in your story about the history of the addiction treatment."

Abstinence from all mind-altering chemicals

- 1953: NA founded in America
- By Jimmy Kinnon, poly drug user & alcoholic
- Addiction treatment, and self-help groups, should not focus on 1 substance



Disappointment with addiction treatment


- Naive
- Fatalistic
- Belittling
- Stigmatizing



Peter Derks, former heroin user

• Methadone clinics are depressing places, chaotic, the workers are badly dressed 'alternative' looking people who have been stuck in one place for too long, and have lost all faith in their clients' ability to become abstinent again. These clinics should be closed. Their negativism rubs off on the addicts.

Context: dominance of methadone maintenance in Holland

- Controversial until 1980
- Strong rise in 1980s
- 12.500 methadone clients in 1993 = about 50% of opiate users
- In 2013: 8185 methadone clients, ± 600 heroin assisted treatment = about 70 % of users




Growth & international dispersion

- Largest growth from 1990 onwards
- From ± 10.000 meetings in 40 countries in 1990; to 63.000 meetings in 132 countries today



NA in the Netherlands

- First meetings late 1980s
- 2006: 23 meetings (13 in Amsterdam)
- 2016: about 180 meetings in 64 towns

Ex-hard drug user Keith Bakker

- 2005: Lawsuit against addiction treatment
- Instead of helping him in becoming sober, they offered him methadone & heroin assisted treatment
- He lost: but trial was good publicity for 12step treatment & NA



± 2005 Addiction treatment under fire nationally

- Critics: clients, family, media
- Claim: addiction treament "gives up on people"
- Lazy, fatalistic attitude





Reactions within public addiction treatment

- Opening of several public 12-step clinics (Minnesota) after 2009
- Closer cooperation with self-help groups, including NA
- Information & Development Centre for Self Help Groups (2003-2008)

NA in broader historical context of Dutch drug user movements

Nico Adriaans (1957-1995)

- Founder Dutch Junkie Unions (1977)
- Acceptance of drug use
- Methadone maintenance, needle exchange
- Activist methods, provocative campaigns



1970s: therapeutic communities



- 1980/1990s: more professional user organisations
- Financially supported, advisors to city councils & treatment field
- Slightly less activist, but with same harm reduction agenda






Junkie Unions & NA compared Shared characteristics

- Strong critique of addiction treatment
- Seeking public attention
- Claim: addiction treatment does not understand addicts/addiction
- Field's interest lies in maintaining public order



Junkie Unions & NA compared Differences

- Junkie Unions fought for harm reduction
- NA fights against (dominance of) harm reduction
- NA = less 'activist' & 'angry'
- NA organisation as such not publicly engaged – individual members are



Conclusion

- Addiction treatment in the Netherlands after 1970 has developed in a dialectical relationship with user groups
- 1980s: Junkie unions helped along the acceptance of harm reduction methods
- 2000s: NA members & 12-step entrepreneurs stimulated a new emphasis on abstinence in the field
- Story symbolizes a fundamental struggle in addiction treatment: finding a balance between acceptance of chronic drug use, and therapeutic optimism
